## ***Wisconsin REALTORS Association Office Descriptions***

**Executive Committee Vice President** (2 positions): Assists the Chairman, Chairman-elect and Treasurer in carrying out the functions of the office and performs specific duties delegated by the Chairman. This position serves solely as an Executive Committee member and does not co-represent any position on the Board of Directors.

**Executive Committee-Director Vice President** (2 positions): Assists the Chairman, Chairman-elect and Treasurer in carrying out the functions of the office and performs specific duties delegated by the Chairman. This position serves simultaneously as a member of the Executive Committee and as a director representing one of the various Director categories and is selected from a pool of currently seated directors.

**NAR Director**: Represents the State at the National Association of REALTORS Director meetings. Term varies from one-three years.
